## DOG & CAT LICENSES

The <u>State of Wisconsin</u> requires that all owners purchase a license each year for all dogs over 5 months of age. The <u>City of Galesville</u> also requires that cat owners purchase a license each year for each cat over 5 months of age. Failure to license your dog(s) or cat(s) could subject you to additional fines or fees. <u>If you own rental</u> <u>properties, you are required to inform your tenants of this law/ordinance.</u> Licenses are available throughout the year at City Hall; the County Treasurer's Office will not provide licenses.

## PLEASE BRING YOUR PET'S CURRENT RABIES VACCINATION INFORMATION WITH YOU TO CITY HALL. I DON'T HAVE THEM ON FILE. NO VACCINATION INFORMATION = NO LICENSE.

If you are requesting a license by mail, <u>submit a copy of the current rabies vaccination information provided</u> <u>by a licensed veterinarian</u>, and be sure the following information is included on the rabies certificate:

- 1) Owner's name & address
- 2) Dog's/Cat's name
- 3) Sex of dog/cat & if it has been spayed or neutered.
- 4) Breed & color of dog/cat

If you wish to receive your license by mail, please include a self-addressed, stamped envelope. Otherwise, they will be available for pickup at City Hall.

Sec. 7-1-22 (c)(1) No family shall own, harbor or keep in its possession more than three (3) dogs on any residentially zoned lot without the prior approval of the Common Council except that a litter of pups or a portion of a litter may be kept for not more than eight (8) weeks from birth. If more than one (1) family resides on a residential lot, then only a total of three (3) dogs shall be allowed on the residential lot unless the prior approval is obtained from the Common Council. For the purposes of this Section, the term "family" shall be defined as one (1) or more persons. Persons may keep more than three (3) dogs only if they have first received a kennel license and a conditional use permit pursuant to the City Zoning Code.
