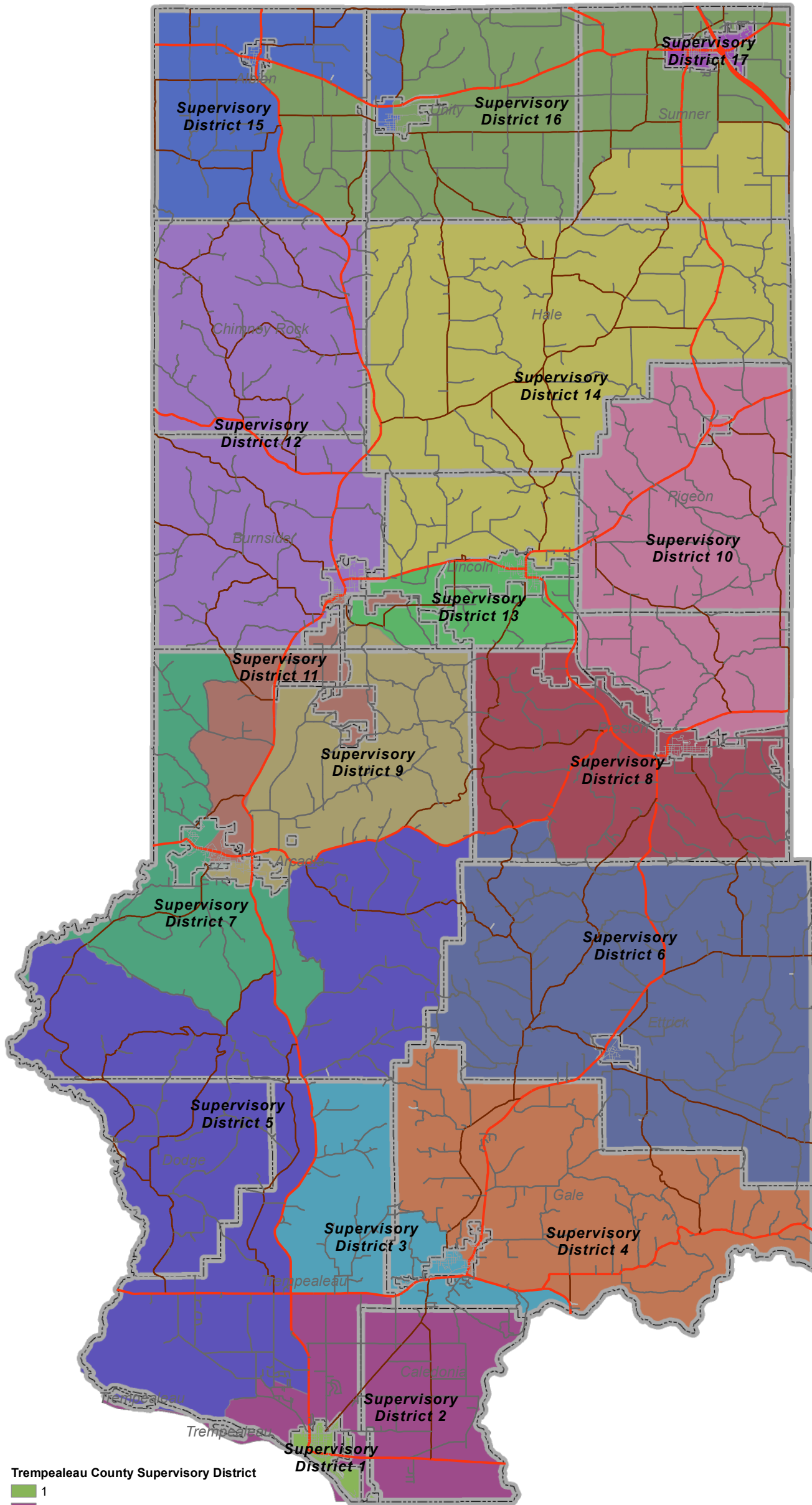


Proposed Final Redistricting Plan for County Board Supervisory Districts after the 2020 Census

District 1 shall consist of Wards 1 and 2 in the Village of Trempealeau.

District 2 shall consist of the Township of Caledonia, and Ward 2 in the Township of Trempealeau.

District 3 shall consist of Wards 2 and 3 in the City of Galesville, Ward 1 in the Township of Trempealeau, and Ward 1 in the Township of Gale.

District 4 shall consist of Ward 1 in the City of Galesville and Ward 2 of Township of Gale.

District 5 shall consist of the Township of Dodge, Ward 3 in the Township of Trempealeau and Ward 4 in the Township of Arcadia.

District 6 shall consist of the Village of Ettrick, Wards 1 and 2 in the Township of Ettrick and Ward 2 in the Township of Preston.

District 7 shall consist of Ward 1 in the City of Arcadia and Ward 3 in the Township of Arcadia.

District 8 shall consist of Wards 1, 2 and 3 in the City of Blair and Ward 1 in the Township of Preston.

District 9 shall consist of Ward 3 in the City of Arcadia, Ward 3 in the Town of Lincoln and Ward 1 in the Township of Arcadia.

District 10 shall consist of the Village of Pigeon Falls, Wards 1 and 2 in the Township of Pigeon, and Ward 3 in the Township of Preston.

District 11 shall consist of Ward 2 in the City of Arcadia, Ward 2 in the City of Independence, Ward 2 in the Township of Arcadia and Ward 4 in the Township of Lincoln.

District 12 shall consist of Wards 1 and 3 in the City of Independence, the Township of Burnside and the Township of Chimney Rock.

District 13 shall consist of Wards 1, 2 and 3 in the City of Whitehall and Ward 2 in the Township of Lincoln.

District 14 shall consist of Wards 1 and 2 in the Township of Hale, Ward 1 in the Township of Lincoln and Ward 2 in the Township of Sumner.

District 15 shall consist of the Village of Eleva, Ward 1 in the Village of Strum, Ward 1 in the Township of Albion and Ward 2 in the Township of Unity.

District 16 shall consist of Ward 2 in the Village of Strum, Ward 2 in the Township of Albion, Ward 1 in the Township of Unity and Ward 1 in the Township of Sumner.

District 17 shall consist of Wards 1, 2, and 3 in the City of Osseo.
